## Hotel and Registration

The SREB Council on Collegiate Education for Nursing Annual Meeting and Conference will be held at the **JW Marriott Hotel** in Atlanta — at **3300 Lenox Road N.E.** The hotel is connected by an enclosed promenade to shopping and dining in Lenox Mall and within walking distance to Phipps Plaza.

The **JW Marriott Hotel Buckhead** has reserved a block of rooms for participants at \$164 per night (single and double occupancy). Board the **Gold Line** headed toward Doraville to the **Lenox Station**. Trains operate from 5 a.m. to 1 a.m. daily.
