Policy Manual (a consolidation of the Policies and Standards document and the FAQ's).

Policies and wording changes in the new Policy Manual include:

- New language about the financial score to consider when an institution has a corporate parent
- Definition for affiliate members
- Language around what happens when an institution loses SARA eligibility
- Section on institutions chartered and owned by US Government
- Clarification that AG's can continue to do their job to apply their consumer protection laws (fraud, misrepresentation and abuse) against any institutions, including SARA institutions
- An index to aid in searching

- There is a 25 percent late fee charged to institutions that do not renew on time.
- Provisional membership was created at the request of one state. We are hoping that it won't be used and that states will work with institutions to fix a problem and then have them return to the application process when a full approval can be given.
