# **Professional Licensure Project Update**

NC-SARA launched its Professional Licensure Project last month. NC-SARA's goal is to bring some efficiency to assist institutions in providing clearer and more accurate disclosures to all students. The data shows that most of the programs leading to licensure among participating institutions are in five fields: teacher education, nursing, counseling, social work, and psychology. NC-SARA and SREB asked each SARA state to provide general contact information for these five licensure boards, which will be housed and managed centrally through the NC-SARA website. If you have not provided this information via the google docs spreadsheet that was emailed from SREB on January 22, 2020, please let us know so your state's information can be uploaded to NC-SARA.
