

Three sub-categories are included: Web; site-to-site, 2-way and audio/video (compressed video); and other, including satellite, cable TV, broadcast TV/radio, closed-circuit, videotape and CD-ROMs.

³ West Virginia used an 80 percent criterion to define e-learning until 2005-06, so figures for the earlier year may be lower than they would be if it used the 50 percent criterion.
