## 2017 High Schools That Work/Technology Centers That Work/Making Middle Grades Work Survey Administration Information

## Overview

The time has come for schools to consider their participation in the SREB Student and Teacher Surveys. The Southern Regional Education Board (SREB) will be offering High Schools That Work (HSTW), Technology Centers That Work (TCTW) and Making Middle Grades Work (MMGW) Student and Teacher Surveys and corresponding reports in 2017. However, 2017 is considered an "off year" and student and teacher survey participation is not a requirement. With that in mind, only schools that elect to take part will be administered the surveys in 2017.

Student and teacher surveys gather perceptions of school and classroom experiences that allow schools, districts and states a unique opportunity to determine what is and is not working to increase student achievement.

The HSTW Student Survey is administered to all or a random sample of at least 60 seniors at HSTW and TCTW sites during their final semester of high school so that their entire high school career can be considered. The survey focuses on the Key Practices and priorities of HSTW and TCTW — high expectations, guidance, extra help, work-based learning, assignments, rigorous career and technical education and more. The student surveys include a transcript section that enables analysis of student course work.

The MMGW Student Survey is administered to all or a random sample of at least 60 eighth-grade students during the winter. The survey is based on the MMGW priorities including school mission, rigorous state standards, a focus on literacy and mathematics, STEM (science, technology, engineering and math), support, guidance and leadership.

Of the schools electing to participate, all teachers, grades nine through 12, should take the HSTW Teacher Survey, and all teachers, grades six through eight, should participate in the MMGW Teacher Survey. Surveys are designed to provide teachers an opportunity to share their insights into school and classroom practices and to indicate the professional development they have received and would like to receive in coming years.
